On behalf of the South Pacific Lawyers' Association, I write in relation to the application for funding from the University of the South Pacific (**USP**) for the Pacific Islands Legal Information Institute (**PacLII**) which was submitted to the Department of Foreign Affairs and Trade (**DFAT**) in December 2023.

The South Pacific Lawyers' Association is comprised of legal professional associations representing seventeen jurisdictions across the South Pacific. It exists to

- represent the interests of South Pacific lawyers on regional issues concerning the rule of law, access to justice and regional law and justice policy;
- support the development of independent peak legal professional associations in the South Pacific region;
- improve the standard of and access to legal education, including continuing professional development for South Pacific lawyers;
- promote effective and robust regulation of the legal profession in the South Pacific;

### Funding for the Pacific Islands Legal Information Institute (PacLII)

I refer to the application from the University of the South Pacific (**USP**) to the Department of Foreign Affairs and Trade (**DFAT**), dated 27 November 2023, which seeks core funding to enable the continued operation of the Pacific Islands Legal Information Institute (**PacLII**) over a period of five years.

As you are aware, PacLII is the principal source of legal information for 20 Pacific Island jurisdictions and is relied upon by the legal profession, judiciary, researchers and the broader community across the Pacific—including Australia and New Zealand. PacLII is administered by USP, with extensive technical assistance from the Australasian Legal Information Institute (**AustLII**).

PacLII is an essential piece of legal infrastructure that underpins the political, economic, and social development of individual Pacific countries and the region as a whole. It is currently the only viable and credible model for the provision of free access to legal materials in the Pacific, due to the limited capacity of many Pacific jurisdictions to provide accessible and consolidated case law and legislation, as well as the prohibitive costs for practitioners to purchase legal materials from commercial providers.

Independent legal associations from across the Pacific—in Tuvalu, American Samoa, the Cook Islands, Fiji, the Marshall Islands, New Zealand, Samoa, the Solomon Islands, Tonga, and Vanuatu—have emphasised the extent to which Pacific legal systems and legal practitioners rely upon PacLII, and describe how PacLII facilitates the delivery of legal

services, supports the development of Pacific jurisprudence, and promotes the rule of law and good governance.<sup>1</sup>

The Law Council welcomed DFAT's extension of critical gap funding to USP to enable PacLII to continue its operations during the 2023-2024 financial year.

This funding also enabled the convening of the PacLII Summit on Maintaining and Enhancing Free Access to Law in the Pacific Region (**PacLII Summit**) in Port Vila, Vanuatu on 5 September 2023. The Summit brought together representatives of governments, courts, non-government organisations, law societies and other stakeholders from eleven Pacific Island jurisdictions, Australia, and New Zealand, and facilitated robust discussion on appropriate governance models, possible funding sources and models to build PacLII's financial sustainability and resilience.

The funding application dated 27 November 2023 reflects these discussions and outlines a proposal to maintain the PacLII service while enhancing PacLII's governance and financial resilience over a five-year term.

This proposal also reflects discussions between the Law Council of Australia, PacLII, AustLII, and USP—as well as with DFAT and the Attorney-General's Department—over the past 15 months regarding PacLII's sustainable operation.

The Law Council strongly encourages the Australian Government to favourably consider USP's application and continue to support PacLII's operations. In doing so, the Australian Government will support the delivery of legal services and access to justice, contribute to effective and accountable governance, and promote the rule of law, stability and prosperity – both in individual Pacific jurisdictions and the region as a whole.

The New Zealand Law Society Te Kāhui i Ture o Aotearoa (Law Society) and the Pacific Lawyers Association of New Zealand (PLA) write jointly to express our support for PacLII and to endorse PacLII's most recent funding application to Australia's Department of Foreign Affairs and Trade (DFAT).

PacLII is a critical resource, both for our Pacific neighbours and for New Zealand. The recent funding application seeks core funding for PacLII for a period of five years to resource PacLII's capacity to maintain and develop existing and new partnerships to support PacLII's longer term sustainability. The Law Society and PLA strongly support this application as being vital to ensure PacLII's continuation of existing services while undertaking the work required to ensure financial sustainability in the long-term.

Pacific peoples comprise 8% of New Zealand's population and 3% of our legal profession. Members of our legal profession are often called upon to assist with matters in Pacific jurisdictions, and members of the New Zealand judiciary (both current and former) serve on the benches in a number of Pacific nations. In many Pacific nations, PacLII is the only database to publish legal material created within those jurisdictions and is the primary resource to access court rules, case law, legislation, and official reports.

For many of our Pacific neighbours, PacLII is the only source of legislation and legal precedent available to practitioners in those countries, as well as providing free public access to legal materials for their communities.

The Law Society and the PLA support the principles of the <u>Montreal Declaration on Free Access to Law</u> to which PacLII is a signatory. In line with these principles, PacLII ensures access to justice which is fundamental to the core principles of democracy.
